


16. Videotape No. 1.11 Title: Flag parade

Contents of the videotape:

1. Jetulla QUARRI "GURI" in the area of KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:00	Flag parade (identical with that of video tape No. 1.34) Formal training, running training (presumably in the area of the HQ of the 113th Brigade). Subsequently, march from the direction of the HQ to a messing facility / accommodation across a bridge, presumably in SLUPCANE.
0:30:00	Together with an NLD group (40 men), "GURI" enters a building where they are having their meal (storage of food). END of the videotape.

Note:

Videotape complements the image of SLUPCANE as base of the 113th Brigade.

17. Videotape No. 1.44 Title: LASHEFC - Sports ground - Water - Free meat - and songs

Contents of the videotape:

1. Jetulla QUARRI "GURI" in the area of KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:00	Environmental pictures, presumably of the region of KUMANOVO. "GURI" and 3 NLA fighters discussing distance data. Subsequently, "GURI" and the 3 fighters on training. Movements across the terrain (in the same region).
0:18:20	("GURI's" cross-country vehicle, already known from videotape No. 1.40, may be seen in the background.) Environmental picture (SLUPCANE).
0:20:27	"GURI" inspects the construction of the obstacle course (SLUPCANE). Lining-up of a group (Rapid Reaction Unit of the 113th Brigade).
0:30:50	"GURI" explains: "... the more training the more improvements..." "GURI" and NLA fighters are drinking water at a creek. Subsequently, lining-up and instructions by "GURI" on the taking in of the meal. Meat is prepared, and one of the fighters mentions the cameraman Agron (presumably Agron IBALLI). Meat is prepared in a smoking room; then, they are having their meal.
0:51:50	Singing of songs. END of the videotape.

Note:

Videotape complements the image of SLUPCANE as base of the 113th Brigade.

18. Videotape No. 1.40 Title: MANASTIRI

Contents of the videotape:

1. Jetulla QUARRI "GURI" in the area of KUMANOVO from May to June `01

Time	Contents of pictures and remarks
0:00:00	"GURI" together with 2 NLA fighters in his room in the HQ (weapons in the background). Briefs the two men on the fire preparation for the position of mortar, cal 120 mm, on the basis of a map 1:50,000. Points of attack are possibly located in the region of KUMANOVO (garrison, leather fabrication, main power supply). Subsequently, "GURI" gives the order to calculate the respective charges for the firing; the attack is scheduled for the early evening hours. Shortly after this order, a bearded fighter shows an SA 7 (similar to the antitank weapon MISTRAL) to "GURI".
0:09:31	"GURI" says that the residual 20 to 30 ea. are to be distributed to the units. The bearded fighter is tasked to pick up Xherat BUJARI.
0:11:33	Xherat BUJARI enters the room with two boys clad in uniforms (one of them carries an AK 47). Date: 15Jun01. Presentation of a song.
0:15:45	Courtyard (presumably in the area of the HQ of the 113th Brigade).

0:21:28	<p>“GURI” squats down at the corner of a house and fires a rifle. Subsequently, he, together with NLA fighters, drives up in a violet cross-country vehicle and fires into the same direction using the machine gun mounted on the vehicle’s roof.</p> <p>“GURI’s” vehicle passes several CPs in the region under control of the NLA (presumably, the NLA has employed own police forces in the area of SLUPCANE)</p>
0:26:34	<p>Shifting of scene: Inside the gray Mercedes Benz from where the pictures were taken.</p> <p>Subsequently, the two vehicles arrive at a large building enclosed by an iron fence.</p>
0:28.43	There, receipt by other NLA fighters for a meal.
0:32:30	Posed round of talks: „Subject: The just war“.
0:36:26	“GURI” and the participants in the round of talks are walking to a church used by the NLA as accommodation. (monastery complex).
0:36:56	
0:43:08	Way back.
0:48:40	<p>“GURI” inspecting battle positions.</p> <p>“GURI” inspecting a communication site captured by the NLA from the FYROM forces.</p> <p>Subsequently, “GURI” continues his journey in the gray Mercedes Benz and fires out of the window. END of the videotape.</p>

Note:

Videotape complements the image of the operational theater of the 113th Brigade.

19. Videotape No. 1.18 Title: Bega – the daughter of SEFA - Event in MULLAPOLIC - K-TAMULI

Contents of the videotape:

1. Commemoration on 13/11/99 in honor of the killed in action Shefket MUHADINI – Commander TAMULI (combat zones LAPUCNIC and RACHOVEC); Islam NEZIRAJ – QERSKORI; Afrim SYLA-OBRIE

Time	Contents of pictures and remarks
0:00:00	UCK music band plays folk music.
1:02:00	Albanian music band plays folk music.
1:25:39	Commemoration on 13/11/99 in honor of the killed in action Shefket MUHADINI – Commander TAMULI (combat zones LAPUCNIC and RACHOVEC); Islam NEZIRAJ – QERSKORI; Afrim SYLA-OBRIE (all names / locations identified phonetically).
1:48:40	Approx. 500 to 600 persons attend the event.
1:56:38	Choir girls of the primary school in STIMJE.
2:21:30	Fatmir LIMA-CELIKU (Ministry of Defense) delivers a commemoration speech.
2:24:30	“GURI” delivers a commemoration speech, followed by
2:27:30	Rushdi JASHARI,

2:28:42	Agim KAMBERI,
2:30:52	Samil LUMA,
2:31:31	Achmed Mustaf ACHMETHI,
2:32:06	Hamdil NEZIRI.
2:35:27	Agron MEHMETI is telling the biography of Commander TAMULI.
2:51:41	Several poems are recited by girls and boys (8 to 16 years old who are „heart and soul“).
	Announcement that now the graves are visited.
	Laying of a wreath. END of the videotape.

Pictures do not provide any essential findings.

20. Videotape No. 1.08 Title: Speech on SLUPCANE

Contents of the videotape:

1. Jetulla QUARRI “GURI” in the area of KUMANOVO in `01

Time	Contents of pictures and remarks
0:00:00	NLA Battalion (80 men) with “GURI” marching along a mountain road.
0:06:46	UCK delegation (60 men) marching on a village road (video tape No. 1.15).
0:08:44	NLA march along a mountain road. Subsequently, with “GURI”, preparation of an ambush (video tape No. 1.34).
0:11:08	Town (presumably SLUPCANE). Shooting in the background.
0:11:19	“GURI” operates a mortar. END of the videotape.

Edited scenes already known from other videotapes.

21. Video tape No. 1.26 Title: New Year 2002 and 2003

Contents of the videotape:

1. Jetulla QUARRI “GURI” with relatives probably in his home in LUBOVCE

Time	Contents of pictures and remarks
0:00:00	Picture at the front end of the room; UCK tablets, pictures.
0:01:02	Picture showing the Brigade 60 KUMANOVA in front of the HQ, led by Commander “GURI”.
0:01:14	Picture showing the Brigade of the 113th RECCE Battalion, led by “GURI” in March `01.
	Approx. 18 persons (men, women, and children) in the drawing room; on the right next to “GURI” his mother in uniform.
0:16:03	“GURI” talking on war / the Army in general.

0:17:56	“GURI” says to the boy at his side: „Where do you have your weapon? Do you want to fight against Serbs? The boy affirms. After that, the boy gets a cleared pistol and walks across the room following “GURI’s” instructions.
0:24:53	Albanian folk group clad in traditional costumes presenting folk music (KTV program).
0:34:11	“GURI” and 5 men are slaughtering a bull. Swift of the camera to the environment (presumably LUBOVCE DM 94 97). Subsequently, cutting-up and preparation of the meat. Trivial talk.
1:12:38	Picture taken in the drawing room, presumably in “GURI’s” home. 12 persons and “GURI”, are watching video scenes from videotape No. 1.39. Shifting of scene to women in the kitchen. Subsequently, men, women, and children watching videotapes (presumably videotape No. 1.39).
1:45:28 2:39:00	Film documentation, dated 18Sep99, on channel tvH. Subsequently, film scene of the feature film “TIRANE“. END of the videotape.

Note:

The videotape probably shows “GURI’s” home and apartment. No additional findings. Acquaintances and relatives are shown in scenes of combat actions, as required.

22. Videotape No. 1.08 Title: Speech on SLUPCANE

Contents of the videotape:

1. Jetulla QUARRI „“GURI”“ in the area of KUMANOVO in `01

Time	Contents of pictures and remarks
0:00:00	NLA Battalion (80 men) and “GURI” marching along a mountain road.
0:06:46	UCK delegation (60 men) marching on the village road (videotape No. 1.15).
0:08:44	NLA group marching along a mountain road. Subsequently, together with “GURI”, preparation of an ambush (videotape No. 1.34).
0:11:08	Town (presumably SLUPCANE); shooting in the background.
0:11:19	“GURI” operates a mortar. END of the videotape.

Note:

Edited scenes already known from other videotapes.

23. Videotape No. 1.27 Title: UCK Army

Contents of the videotape:

1. Jetulla QUARRI "GURI" in the area of KUMANOVO in `01

Time	Contents of pictures and remarks
0:00:00	(May `01?) Meeting of AHMETI, "GURI" and other NLA fighters. "GURI": "...when we will enter CAMARIA (village between ATHENS and THESSALONIKI where ethnic Albanians live) we will have captured half of GREECE..." Laughter, indistinct talk (trivial).
0:04:42	"GURI" together with NLA fighters in the backyard with an anti-aircraft gun.
0:06:09	"GURI", observing the terrain, says: "...via PRESOVO to BUJANOVAC (EN 63 01)."
0:08:01	Date: 05May01. Town (SLUPCANE). Subsequently, "GURI", together with an NLA group and mules, passing through a town (videotape No. 1.34).
0:25:15	"GURI" observing the terrain. Several NLA fighters in battle position (approx. 30 men with anti-tank gun). This is followed by a march with rest halt. The group continues the march in order to meet other units.
0:41:45	"GURI" explains to the lined-up men that everyone fouling things up will be penalized on the spot since there is no time for other procedures. Those who do not respect their superiors will immediately be employed to the HQ and excluded from action duty, says "GURI". Subsequently, "GURI" talks of the idea that all regions settled by Albanians will have to be unified.
0:43:52	"GURI": "...our Army, formed in the course of the war, is superior to the Serb, Macedonian, and Montenegrin Armies... The country borders will fall in the near future... Due to your efforts and your sweat, the Albanian people will be unified... Nowadays, we are crossing the border between the KOSOVO and ALBANIA without hindrance. This is just the same with MACEDONIA... And there are also PRESOVO, BUJANOVAC, MEDVEDEV, and CAMARIA; this is also Albanian soil that remained divided..."
0:47:08	NLA marching group (already shown on other videotapes)
0:54:25	UCK marching group (already known from other videotape No. 1.15).
0:55:39	Other marching groups already shown on other videotapes.
0:57:31	Ambush scene (already shown on videotape No. 1.34).
0:58:21	"GURI" operates a mortar (already shown on other videotapes).
0:59:24	Courtyard and building of the HQ in SLUPCANE already shown on previous videotapes. Weapons training, running, etc. "GURI" fires submachine gun responded by counter-bombardment fire (tracer projectile). Date: 21May01 (videotape No. 1.39).
1:27:17	"GURI" on brush-covered ground firing submachine gun.
1:31:10	Courtyard, presumably in the area of the HQ in SLUPCANE. Subsequently, scene with mortar (videotape No. 1.34) Date: 21/22 May.

1:47:00	NLA marching group (already known from previous videotapes).
1:52:12	END of the videotape.

Note:

Some scenes / combat actions are already known from previous videotapes. “GURI” talks again of the war until the Albanian soil is united.

24. Videotape No. 1.42 Title: TOPI near the firs - “GURI”

Contents of the videotape:

1. Jetulla QUARRI “GURI” in the area of KUMANOVO in June `01

Time	Contents of pictures and remarks
0:41:00	Road construction (already known from videotape No. 1.19), presumably coordinate (515 687)
1:14:03	End of the videotape.
