




25. Videotape No. 1.12 Title: UCK-2 - Visit by Commander MALIQI at the unit and “GURI” – Armament cleaning

Contents of the videotape:

1. Jetulla QUARRI “GURI” in the area of KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:00	Date 30May2003 (presumably 2001). “GURI” and “MALIQI“ inspecting armament cleaning.
0:04:29	“GURI” sits at a table in a room copying something from a military instructions book (HAWA and the effects / performance), skims through the book. “GURI” sends for 2 unit leaders.
0:12:25	The first unit leader appears saying that his unit has made an exercise “Rescue of injured”. Afrim KALANICA appears (second unit leader – mentioned in the title of videotape No. 1.23).
0:13:46	“GURI” asks for the current situation / status of mine laying in the area of SLUPCANE (EM 52 70), above ALASEVCE (EM 488 705), and between IZVOR (EM 48 72) and BELANOVCE (EM 465 760).

0:15:21	And he is asking for the chances of an attack in QARISHTA (phonetical identification). “GURI” gives order to the messenger “ILIR“ to send the soldiers to the two road crossings, as agreed. This is followed by instructions to the men present to be careful and by a discussion of the tactical approach (hit and run). After that, the “usual” statements regarding the situation of the Albanians and trivial talk on the decidedness of the Albanians in FYROM.
0:26:04	“GURI” gives the instruction to one of the unit leaders to read the military book in order to learn how anti-personnel mines are laid and to come to know the effect of antitank weapons.
0:27:20	End of the conversation. “GURI” studies a map (the region of SLUPCANE and further villages are marked).
0:28:29	A fighter named “Xhevat“ enters the room. He is reprimanded by “GURI” for carrying no weapon.
0:29:41	An NLA fighter enters the room saying that the scout Arben is required in the village as interpreter (hint to the questioning of prisoners?).
0:31:40	“GURI” says he should go to „Xhevat“.
0:32:04	“GURI” says that they have had a coffee in KUMANOVO and they will do the same in SKOPJE. This is followed by tactical instructions. Xhevat is ordered to take the map and leaves. END of the videotape.

Note:

Further findings may be gained when this videotape is viewed in context with other KUMANOVO scenes.

26. Videotape No. 1.31 Title: UCK - 2 cassettes – The action in KALANICA

Contents of the videotape:

1. Jetulla QUARRI “GURI” in the area of KUMANOVO in `01
2. Questioning of prisoners in SLUPCANE

Time	Contents of pictures and remarks
0:00:00	“GURI” climbs a slope.
0:16:30	“GURI” gives instructions regarding the situation and extension of the battle position (shooting in the background). Swift to the environment.
0:26:21	The woman already known from various scenes is called “ILIRIA“. Date: 05May01.
0:28:06	Environmental pictures. Mortar location behind the cameraman. “GURI” walking to the operational area of the NLA group. Bursts in the area of the opposite slope.
0:38:32	NLA fighters at the mortar location return fire.
0:42:00	“GURI” returns to the mortar location and fires the mortar himself. After

0:47:00	that, repositioning.
0:55:20	March of some NLA fighters, presumably change of position.
0:57:38	“GURI” at the submachine gun in brush-covered ground (beginning of the scene already known).
1:14:35	Date: 05May01.
1:19:52	Swift to the foreland; subsequently, the camera is directed to the sky. “GURI”, Xhevat, “ILIRIA”, and NLA fighters in the terrain, bent over a map (the course of the road SLUPCANE – VASINCE is marked). “GURI” says: „...on 02 May, SLUPCANE was declared a free zone, on 03 and 04 May, we had war, and today (05 May) we will bomb the villages surrounding SLUPCANE.“ After that, “GURI” is talking as “usual” of the Albanian soil.
1:32:00	On 06May01 “GURI” with mules and NLA group marching to a armament depot in SLUPCANE (already known from other videotapes. Now the scene is shown in context).
1:41:32	Mules are loaded.
1:48:56	Fighters are advised to tie up the mules and have a rest. Red-white house with well. “GURI” salutes a “Shaban“, enters the house and a room (room from where he had fired the Scorpion submachine gun). “ILIRIA” hisses flag (presumably, she is responsible for the furnishing of “GURI”s rooms). “GURI” takes his equipment off.
1:58:52	A night vision aid is brought.
2:05:45	“GURI“ lists the ammunition to be picked up at the depot.
2:06:20	“GURI” talks of the combat actions, the operation of helicopters by FYROM on 04May01 and reports bursts at the opposite slope the day before (0:42:00).
2:09:17	One of the persons present reports somebody had circulated the rumor that the NLA would demand for a ransom of 20,000 DM for their prisoners. This is followed by the “usual“ talk on the subject: “the just fight for freedom“.
2:14:08	An NLA fighter enters the room. “GURI” asks for the situation. The NLA fighter says that their fight was successful.
2:27:54	“GURI” and “ILIRIA” in the courtyard.
2:31:31	Date: 06May01. “GURI” inspects the battle position of the advanced confrontation line in SLUPCANE (probably the north-estern fringe of the town) and gives instructions on the extension and camouflage.
2:43:20	“GURI” salutes the Commander (ZENA?). “GURI” gives further instructions on the extension and camouflage of the operational area. After that, agreement re the tactical approach of the defense of SLUPCANE.
2:55:35	Date: 06May01. “GURI” visits an NLA group of his battalion in a house (probably the company’s battle position in SLUPCANE).
2:59:03	“GURI” controls a road guard in the town.
3:00:00	“GURI” on site inspection in a white Opel ASCONA (GE registration No.: WM-SC 668). “GURI” intends to visit all his subunits.
3:03:25	“GURI” at one subunit in a house. END of the videotape.

Note:

Edited scenes already known from other videotapes. Questioning of prisoners = key scene.

27. Videotape No. 1.06 Title: "GURI" – 50th Signal Battalion

Contents of the videotape:

1. TMK event

Time	Contents of pictures and remarks
	Same TMK event, dated 25Jul02, as shown on videotape No. 1.16 from 0:53:00 to 1:20:25. End of the videotape.

Note:

Picture does not provide any essential findings.

28. Videotape No. 1.43 Title: National Liberation Army (UCK-MKD) - KALENCIAR - MUJOTA

Contents of the videotape:

1. Jetulla QUARRI "GURI" in the area of KUMANOVO in May/June `01

Time	Contents of pictures and remarks
0:00:00	NLA training; subject: antitank mines and antipersonnel mines. Trainees come from "GURI"'s battalion.
0:05:20	"GURI" enters a house (followed by Xhefet) (already shown on videotape No. 1.34, now in the right context of scenes). "GURI" is talking of the KOSOVO war saying that he has fought side with Commander FERRIT, Naim BEKA, Nozim HAIDACI and Islam ELSHANI.
0:18:50	A boy, approx. 16 years old, is incorporated in "GURI"'s unit (equipped with uniform and AK47) (one NLA fighter with name label SUKI). This is followed by war stories by "GURI". Contents: Co-fighters were: Ramzi SHALLA, Skender TERSHANI, Shaqir TERSHANI, ex-Commander of the Brigade 121 CELIKU. On 15Jun (98?), the Battalion of the Rapid Reaction Force was created at GREEKERS.
0:30:20	After KUMANOVA's death, the Brigade was subordinate to the HQ. Subsequently, "GURI" talks of preparations for the establishment of the UCK in `92.
0:35:00	Names mentioned: Ali MULLINI, LUANI SYLA, ELEZI. NLA fighters singing a march song.

0:37:15	“GURI” leaves the paneled room in order to visit other units (on the right, a barred archway is shown).
0:39:24	“GURI” during an arms inspection in front of the house where the previous meeting took place. After that, an NLA group marching into the direction of the mentioned archway. Subsequently, the same group at rest in a courtyard.
0:43:02	
0:51:35	“GURI” appears. END of the videotape.

29. Videotape No. 1.30 Title: TV casting on Special Unit “Black Tigers”

Contents of the videotape:

1. Scenes of various TV castings

Time	Contents of pictures and remarks
0:00:00 - 0:33:11	Various scenes of TV castings on the course of the KOSOVO crisis in `99. Scenes of the broadcasters ntv (GE) / Euronews (GE), HR ^t (Croat), CCN, (US), 3-sat (GE), Phoenix (GE), SF1 (Switzerland), ARD (GE), ZDF (GE), ARTE (GE), RTS (Serbia). Feature on the subjects: Assassination of AGALIS, course of the war; situation of refugees, and massacres.
0:33:11	Short feature on the Black Tigers; subsequently, other castings on the KOSOVO crisis (most of them repeats of previous scenes).
1:28:28	Repeats of the feature on the Black Tigers, followed by repeats of previous TV castings.
3:03:31	END of the videotape.

Note:

No essential findings. Some of the pictures could have been made available to “GURI” by acquaintances from Switzerland and Germany.

30. Videotape No. 1.13 Title: UCK - 23.05.01 - for the determination of points – Organization

Contents of the videotape:

1. Jetulla QUARRI “GURI” in the area of KUMANOVO in `01

Time	Contents of pictures and remarks
0:00:00	“GURI” and an NLA group on their march to the operational area north of SLUPCANE (presumably on 03May01 in the morning).
0:00:57	“GURI” settles the position of the confrontation line by mobile phone.

0:31:00	Subsequently, installation of a mortar. Follow-on march.
0:35:21	“GURI” studies map and uses a mobile phone saying: ...1, 2, 3, 4, 5, 6 are informed, 7 has formed-up and is marching in the direction of VASINCE (battalion-size, approx. 160 men?). “GURI”’s group comprises approx. 20 men. Contents of the phone call: “...ask a superior, they know where we are and will inform you...”
0:38:57	Then, follow-on march.
0:42:16	Installation of a mortar. Some fighters of the group are instructed by “GURI” to observe the convoys and to note where the vehicles are moving / persons are doing.
0:44:03	“GURI” gives order to “ILIRIA” to find civilians for additional support. Civilians get the order to support the preparation of the mortar location.
0:49:43	Subsequently, “GURI” and part of his NLA fighters deploy in the right-hand area. Picture of a “military base“ of the FYROM Forces. 2 armored vehicles enter the base (“GURI”’s assault objective) (“GURI”’s operational area in the region of coordinate EM 525 700). The northern fringes of the villages of OPAE / REZANOVCE and KUMANOVO are shown.
0:52:32	“GURI” gives firing command at the mortar location that is followed by two mortar firings a few minutes later.
1:00:03	The cameraman and “GURI” evaded to the rear to the brush-covered ground (combat operation in the background).
1:16:51	Picture of the base. Subsequently, the cameraman hides in brush-covered ground. Helicopter noise, first increasing and then decreasing. “GURI” and his men have conducted a change of position (located above the old position).
1:26:51	Installation of mortar location. An NLA fighter moves to the top of the slope and reconnoiters where the vehicles are. Date: 03May01.
1:46:18	“GURI” fires several mortar projectiles. Subsequently, he evades together with his men. This is followed by their march back, presumably to SLUPCANE.
1:51:10	Date: 04May01. NLA group with “GURI” on their march with two pack animals (mules). The group having a rest. “GURI” commends the satisfactory course of yesterday’s attack. One of the group is an ex-soldier of the FYROM Forces, named Nezir DEMIRI, from the vicinity of KUMANOVO.
2:06:30	According to him, he is a defector. Another soldier, Mohammed JUSUFI, also is a defector who joined the group 2 days before.
2:11:48	“GURI” gives the order to lay mines. “GURI” and his fighters on their march.
2:22:00	“GURI” instructing his subunit leaders on the further approach (presumably, Xhafer is unit leader). Subsequently, “GURI” admonishes his men to comply with discipline and basic military obligations.
2:23:35	
2:28:00	
2:30:45	

2:42:30	<p>“GURI”’s fighters observe the approach of the FYROM Forces (not recognizable on the videotape, acoustic combat noise only).</p>
	<p>Lining-up of “GURI”’s Battalion in SLUPCANE.</p>
2:51:37	<p>“GURI” orders 2 platoons in the direction of KUMANOVO. 2 other platoons are to stay with “GURI”.</p>
	<p>In a conversation with his supposed Deputy, “GURI” confirms that his units are stationed in SLUPCANE.</p>
3:03:00	<p>For a moment, ILIRI appears on the scene.</p>
	<p>“GURI” gives instructions to his fighters and to the civilian population supplying the unit with food.</p>
	<p>“GURI”, ILIRI, “GURI”’s Deputy, and other subunit leaders in the courtyard.</p>
	<p>END of the videotape.</p>
