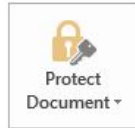


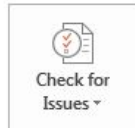

38. Video tape No. 1.22 Title: Mine launcher, cal 120 mm - Gun for air defense

Contents of the video tape:

1. Jetulla QUARRI "GURI" in KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:00	Noise of battle (night picture), black picture. Tracer projectile shot from the direction of the camera.
0:08:00	In the background, "GURI" gives instructions not to leave the line; the situation to the left and to the right is requested.

0:14:08	After the burst of a tank shell, the situation is requested followed by the instruction to fight the tanks with mortars. Picture was probably taken inside a building.
0:26:23	“GURI“ with NLA fighter in the area of the supposed HQ in SLUPCANE. “GURI“ gives the instruction to emplace the antitank weapon. Subsequently, he walks to an anti-aircraft machine gun (repetition of the pictures of video tape No. 1.39 starting with 0:26:20).
2:15:21	Camera pan to the rear: one group of NLA fighters together with GURI in front of the house. The camera is placed on the ground; the following scene: preparation of a mortar, cal 120 mm (video tape No. 1.34). Date 22May01.
3:03:00	END of the tape.

39. Video tape No. 1.45 Title: Demonstration on the occasion of the 3rd anniversary of the KFOR helicopter - Ismet JAHSHARI, TOPI, GURI, G. OSTREMI, A. AHMETI

Contents of the video tape:

2. Jetulla QUARRI “GURI” in KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:51	“GURI“ and NLA group are marching along a road (scene known from previous video tape (without sound)).
0:03:00	NLA event in FYROM on 25Aug01 on the occasion of the 3rd anniversary of Ismet JASHARI’s death (COMMANDER “KUMANOVA“). Repetition of video tape No. 1.16 starting with 0:04:34 (without sound).
1:18:44	A. AHMETI together with various commanders in a round of talks following the event. Subsequently, change of scene to a room where AHMETI has a conversation with “GURI“ and other NLA Commanders (without sound).
2:04:28	Repetition of the scene with anti-aircraft gun.
2:09:53	AHMETI with “GURI“ and an old NLA leader in a garage.
2:11:00	A helicopter is landing on a site near a road; someone (AHMETI?) boards the helicopter that is subsequently breaking ground again. GURI and NLA fighters are marching along the road towards the camera. Another helicopter during its landing operation (TFH).
2:13:45	“GURI“ observes apron area; NLA fighters arrive with antitank gun that they are emplacing. Subsequently, GURI moves through the battle positions along the mountain road.
2:30:40	“GURI“ deploys together with the NLA group, then, the group makes a rest halt. This is followed by a lining-up with “GURI“ talking to his men (scenes of the previous video tapes now in the right context).

3:03:45	END of the tape.

40. Video No. 1.04 Title: MATEC – Tanks - Construction of protective shelter - Visit at the Commander`s

Contents of the video tape:

1. Jetulla QUARRI “GURI” in KUMANOVO in May `01
2. Possible torture scene

Time	Contents of pictures and remarks
0:00:00	“GURI“ is in a room and has radio contact with a “KULLA“. Subsequently, an NLA fighter enters the room and gives a situation report. Later on, 5 other NLA fighters enter the room (the 3rd is the one of the torture scene) (probably all of them subunit leaders); they are all reporting that everything is okay and in progress. This is followed by a general briefing on the military actions taking place to date.
0:09:27	“GURI“ says that the FYROM forces in the region around SLUPCANE experienced high losses from the beginning of the war to date, on 10Jun01.
0:13:00	This is followed by trivial descriptions. It is reported that the Macedonian military base in VAKCINCE is screened by 8 tanks. According to “GURI“, the friends from KUMANOVO had reported that another 15 tanks reinforce the front line. Subsequently, it is told that the Macedonians are making raids in the villages, looting the Albanians, and that this fight is justified. Subsequently, “GURI“ explains how the military actions started and how everything was organized (war and parallel NLA structure).
0:17:50	“GURI“ reports to have collected the people from the villages around SLUPCANE and trained them to become NLA fighters. Due to its infrastructure, SLUPCANE is well suited as base camp, and the inhabitants were impressed by the NLA and stood by them. Later on, “GURI“ mentions that he has met the Commanders “MALIQI“, “TIGRI“, “DAJA“, and “SANIU“ in order to establish plans. Subsequently, his „usual statements“ regarding the Albanian soil and the fight for freedom.
0:22:19	Date 10Jun01
0:22:40	“GURI“ is asked for his opinion regarding the fight in the surrounding villages now lasting 40 days. He responds that the war, starting on 03May01 and lasting to the 10Jun01, is conducted by the entire people; after 100 years, we have again morale, courage, and a unified people.
0:24:00	The man clad in black and with a gray beard says that 15,000 grenades had been fired to SLUPCANE but that the inhabitants did not take to flight but

0:32:23	<p>hided in their cellars. Subsequently, again talk about trivial things. “GURI“ contacts “EAGLE 7“ and gives the instruction to be watchful. Subsequently, again talk about trivial things.</p>
0:44:30 0:50:33 0:55:30	<p>“GURI“ sits together with older NLA fighters and eats; the TV shows a heroic video while “GURI“ is talking about trivial things. Date 11Jun01. Two other NLA fighters enter the room; trivial talk about the present situation.</p>
0:56:36	<p>“GURI“ together with several NLA fighters during their move forward probably in MATICE (EM 49 64). A wrecked tank and destroyed houses can be seen. They are trying to shoot a domestic pig at a distance of approx. 50 m but without success.</p>
1:04:14 1:12:01	<p>“GURI“ and 3 NLA fighters have a closer look at the wrecked tank. “GURI“ contacts “EAGLE 1“ giving the situation report that everything is okay. Subsequently, “GURI“ goes to a stable and has radio contact with his units. “GURI“ says that the radio participant shall report the situation to the police who will then contact him. (establishment of own police forces); subsequently, he presumably contacts a guard who tells him that someone wants to go to LIPKOVO. “GURI“ instructs him to take care that the unknown person is escorted to the crossing in SLUPCANE by “EAGLE 1“ and is allowed to pass.</p>
1:13:10 1:26:40 1:28:46 1:32:00 1:32:50	<p>“GURI“ again on his move forward across the town in the vicinity of a former Macedonian police station with wrecked police cars in the environment. Subsequently, “GURI“ says to an NLA fighter that the area of the police station has not yet been searched for mines/booby traps. Then, “GURI“ continues to look around. In the school building, a box is examined for booby traps. An NLA fighter reads on the table: “Death to the Albanians, they are only meant for liquidation.“ Old teaching subjects may be made out as well as at upper left: 57th Army SCORPION. “GURI“ and his men enter the area of the church. Situation briefing with an NLA fighter who says that there are neither inhabitants nor security forces in VISTICA (EM 49 61). “GURI“ says that, on his order, the hills and houses shall be occupied by and by. First, the RECCE forces shall examine the town and it shall be checked whether the HQ may be employed in the area of VISTICA. Environmental picture.</p>
1:33:25	<p>Probably the inside of the water pump room of the church. Subsequently, “GURI“ and an NLA fighter enter a church; it is estimated that no mines have been laid there. A dog is named the master of the Macedonians. The cameraman says “GURI“ shall examine and destroy the pictures. An NLA fighter, presumably “GURI“, shoots at the chandelier.</p>
1:38:05	<p>“GURI“ together with the fighters on their way back to the wrecked tank.</p>
1:38:40	<p>A vehicle loaded with logs drives into the picture.</p>

	“GURI“ surveys the construction of a battalion shelter.
1:49:07	“GURI“ is sitting in a room with a green-gray couch. An NLA fighter (with red stains in his face (blood stains?) and red-stained hands (blood?) enters the room saying that he has successfully finished work a hundred percent. “GURI“ asks: “A hundred percent?“ The fighter answers: “Yes, a hundred percent.“
1:51:21	“GURI“ asks: “How are the friends?“ The other answers that they are fine. Then, “GURI“ is asked how the others are, and he answers that they are also fine. “GURI“ asks for the RECCE forces. The other answers that they are also fine and that he recently was ahead with them. Then, “GURI“ says that the other shall bring his group here as soon as possible. After that, the other leaves the room. (In the background, a woman’s voice, several men’s voices, the noise of slapping/knocking as well as three partly long-drawn-out cries may be heard in the course of the conversation.)
	END of the tape.

The voice of the crying person is similar to that of the Slav-Macedonian prisoner who pretends to be a worker in a monastery. The room is
