

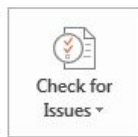

41. Video tape No. 1.29 Title: SLUPCANE – K. DOKTORI - Preparation with boiler

Contents of the video tape:

1. NLA fighters constructing bombs

Time	Contents of pictures and remarks
0:56:16	Date 29May01. The readiness of the unit is reported to the Commander of a RECCE unit. The picture is taken in a battle position trench. One shelter was hit by a tank shell resulting in 2 casualties. The trench has a length of approx. 100 m.
1:30:55	Something shall be released at 0245 hrs (black picture; shots may be heard).
1:31:33	NLA group (bomb constructors) in a room, some of them have blackened faces; loud music. Date: 04Jun01); some are firing several shots with their pistols.
1:35:52	END of the video tape.

1. Jetulla QUARRI “GURI” in KUMANOVO in `01

Time	Contents of pictures and remarks
0:00:00	“GURI“ together with NLA fighters at a mountain slope, fires with a pistol.
0:01:34	NLA group is marching along a village road (voices and shots are heard in the background).
0:32:28	NLA group is leaving the village and marching towards the mountain slopes. Subsequently, marching sequences already known (i.a. with camouflage material), now in the right context. In the direction of the camera, “GURI“ swears his oath to free the Albanian soil up to CAMERIA together with the NLA. NLA group is marching to the accommodations.
0:36:46	NLA group on their way to prepare the ambush and battle positions of the ambush, followed by their march back (video tape No. 1.34 and follow-on videos).
1:00:18	“GURI“ together with a delegation clad in national costumes (the HOXHA of SLUPCANE is also present). The „shelter of the battalion“, constructed
1:02:15	the evening before, is shown. END of the video tape.

0:00:00	TMK gate taken from a vehicle – beginning of the event already shown on video tape No. 1.16. TMK event on 25Jul02 on the occasion of the 50th Signal Battalion “SHAQIR TERSHANI“, presumably in VATICAN.
0:33:29 0:34:34	Poem on the UCK fighter Afrim KALANICIA, recited by a girl.

45. Video tape No. 1.07 Title: March of unit - Visit by the Commander - MALIQI in military units - Cleaning of armament and command

Contents of the video tape:

1. Memory of the killed in action
2. Marching scenes

Time	Contents of pictures and remarks
0:00:00	“GURI“ and the father of SKIFTERI review the honor detachment (lining-up in the courtyard presumably of the HQ (minute’s silence for the 4 killed in action, i.a. SKIFTERI). The mother of the killed in action is also present.
0:03:26	“GURI“ and delegation employ to the burial place.
0:05:38	“GURI“ orders the NLA group to line up and exercise. Subsequently, the group leaves and employs to the mountain slopes. (All in all, these are pictures ahead of those on the video tape No. 1.41 starting with 0:01:34).
0:27:56	The same NLA group lined-up in front of the obstacle course (SLUPCANE). “GURI“ admonishes the group to comply with discipline and basic military obligations. Subsequently, beginning of cross-country movement (scenes already known from previous video tapes but now in the right context; pictures partly taken from a driving car), followed by the group passing through a town. END of the video tape.

46. Video tape No. 1.10 Title: Visit of the points

Contents of the video tape:

1. "GURI" inspects the area of the battle positions in MATEJCE

Time	Contents of pictures and remarks
0:00:00	"GURI" and Commander "MALIQI" are moving across a system of battle positions. The trenches have a length of presumably approx. 700 m. During this scene, Commander "MALIQI" is wearing an UCK insignia of rank for the first time, presumably that of a Brigadier General.
0:07:49	Contents of an incoming radio message: "Take the two red cars and the jeep and bring them to JACOVA 1 (phonetical identification)."
0:11:24	Lining-up of the unit (approx. 30 men) in a courtyard. "MALIQI" delivers a speech on the military goals achieved. MALIQI says that the NLA fighters are no longer what they have been only one or two months ago.
0:13:11	"GURI" and Commander "MALIQI" again at the trench position extending from a town across an open space. Pictures of destroyed houses (presumably in June/July '01).
0:20:21	"GURI" gives instructions regarding the defense of the battle position saying that HOXHA is employed on their right. Subsequently, "GURI" and several fighters are passing through the town.
0:20:41	
0:22:12	"GURI" enters the courtyard of a house and orders the NLA group (12 men) of the specific RECCE forces of the 113th Brigade to line up by firing into the air. "GURI" gives advice to his men always to be ready, saying: "When we practice readiness for 3 months and do not pay attention only once - that was the war." Then he asks whether the radio connections to the other units are complete which is confirmed by his unit leader. Subsequently, the towns of SLUPCANE, ORIZAI, ARACHINOVO, and MATEJCE are mentioned with respect to their resistance offered. Having sworn the men to the war, "GURI" leaves.
0:29:27	"MALIQI" and "GURI" are inspecting another area of battle positions at the fringe of a town. Pictures of the environment are taken.
0:34:43	The police station in MATEJCE is taken from a driving car.
0:35:19	"MALIQI" and "GURI" are inspecting another area of battle positions. Pictures of the environment are taken where a mill is shown.
0:38:05	"MALIQI" and "GURI" are driving towards the known wrecked tank. Subsequently, they are sitting in a garden presumably in the area of the HQ in MATEJCE.
0:40:10	"GURI" and some NLA fighters are passing through, possibly, MATEJCE, reconnoitering / inspecting the environment.
0:45:00	Again, pictures are taken of the wrecked tank. "DOKTOR" drives to that area in a cross-country vehicle, followed by a Mercedes Benz and shortly addresses "GURI".
0:49:14	Picture of the environment; a mill is shown.
0:51:16	"GURI" is inspecting another area of battle positions. Pictures of the apron area / environment are taken; "GURI" gives some

1:00:57	instructions. “GURI“ observes the apron area. END of the video tape.

0:18:14	Albanian feature film „TIRANE, May 1920“. END of the video tape.

0:02:50 - 0:10:12	Pictures of movements of Serb combat vehicles (several BTR 70/80? four-axes armored transport vehicle) taken from a battle position.
0:11:02	10 UCK fighters in an apartment.
0:11:45	7 UCK fighters in battle position.

0:11:56	UCK group with submachine gun in the forest.
0:12:22	Environmental picture.
0:13:30	UCK group in battle position in the forest. Picture of a bridge and town.
0:15:15	UCK fighter in conversation with a baker in a bakery preparing the bread for the fighters. 1,000 breads are delivered daily.
0:19:54	Picture of the advance of UCK fighters in a town (the Commander of the 2nd Battalion is with the group „cleansing houses“.
0:24:26	Burning houses of a town. Date: 25Mar99.
0:24:41	House is set on fire at night.
0:25:11	Burning houses.
0:25:48	UCK fighter is drinking from a puddle.
0:27:42	Sleeping UCK fighters, approx. 20 men.
0:31:24	UCK fighters (approx. 30 men) marching in a forest.
0:32:29	Date: 15May99. Picture of town.
0:36:25	The area of an access route under fire from a battle position.
0:37:37	Date: 16May99. UCK fighters in battle position.
0:40:39	Date: 17May99. UCK collection center.
0:48:56	UCK fighters in trench position at mountain slope (shots in the background).
0:49:36	Date: 08Jun99. UCK fighters (7 men) having a break.
0:30:22	Picture of a jet, probably NATO Tornado.
0:50:16	UCK fighters, having had their break, now in battle position.
0:55:10	Advance of UCK fighters across the terrain, presumably training.
0:57:58	Lining-up, presumably of recently recruited fighters. The PASTRIKU zone is mentioned. Commander Tahir SINANI delivers a speech in the honor of the killed in action.
1:06:17	Lining-up of UCK fighters; “GURI” appears.
1:08:34	“GURI” talks to 3 UCK fighters.
1:14:31	Date: 06Jun99, 1000 hrs. UCK fighters are digging a battle position in a wood area. 1800 hrs. Picture of mortar bursts in the ground. Date: 07Jun99. Crater of mortar burst in the ground.
1:17:08	Date: 10May99. 3 UCK fighters „picture of heroes“.
1:32:21	Date: 28May99. Bombardment of a town.
1:36:39	Date: 03Jun99. Interview with Commander ELASHI at the confrontation line.
1:38:20	114th Brigade in the area of MILLAROSI (phonetical identification). Interview with UCK fighter “PROFESSOR“, leader of the 2nd Group, 1st Platoon, 1st Coy, of the 121th Brigade „ELASHI Battalion“. According to him, the Serbs are weak and will not penetrate here.
1:40:08	Interview with leader, 1st Coy, of the 121th Brigade „ELASHI Battalion“. According to him, ammunition and food are sufficient, and the men are highly motivated.
1:43:10	

	UCK fighters in battle position. Preparation of food.
1:55:15	Date: 04Jun99. UCK fighters emplacing a mortar.
1:58:10	UCK fighters (approx. 25 men) marching across terrain.
2:00:35	Casualty collection center.
2:21:56	Date: 05Jun99. Leg operation of a female (presumably a mine injury). Interview with person with face injuries telling that he was arrested and questioned (and maltreated) by the Serb Military Police. 4 co-prisoners were designated to be shot; the injured managed to take to flight but sustained a gunshot wound. Interview with two persons reporting massacres in several villages in the area of SHAVARINA (phonetical identification) on 16Apr99.
2:39:30	Attendance of gunshot wound. END of the video tape.

Presumably, a great part of the pictures was made in the PASTRIKU zone.
