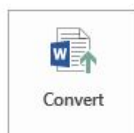


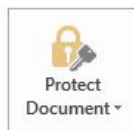

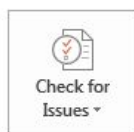

0:02:53	Date: 07May01. “GURI” at submachine gun.
0:04.24	“GURI” in civilian clothes together with several persons (i.a. TMK members) erecting an UCK memorial stone (night picture). Truck with the inscription KASTRIOTI.
0:18:14	Albanian feature film „TIRANE, May 1920“. END of the video tape.

Pictures do not provide any essential findings.

1. Pictures of UCK fighters and various events in the period from March to June 1999

0:00:04	Environmental pictures.
0:00:05	Picture of a dead UCK fighter.
0:02:15	UCK fighters are carrying the corpse to the grave.
0:02:50	Picture of a town under fire taken from a battle position at a mountain slope. Date: 1998/99.
0:02:50 - 0:10:12	Pictures of movements of Serb combat vehicles (several BTR 70/80? four-axes armored transport vehicle) taken from a battle position.
0:11:02	10 UCK fighters in an apartment.
0:11:45	7 UCK fighters in battle position.
0:11:56	UCK group with submachine gun in the forest.
0:12:22	Environmental picture.
0:13:30	UCK group in battle position in the forest. Picture of a bridge and town.
0:15:15	UCK fighter in conversation with a baker in a bakery preparing the bread for the fighters. 1,000 breads are delivered daily.
0:19:54	Picture of the advance of UCK fighters in a town (the Commander of the 2nd Battalion is with the group „cleansing houses“.
0:24:26	Burning houses of a town. Date: 25Mar99.
0:24:41	House is set on fire at night.
0:25:11	Burning houses.
0:25:48	UCK fighter is drinking from a puddle.
0:27:42	Sleeping UCK fighters, approx. 20 men.
0:31:24	UCK fighters (approx. 30 men) marching in a forest.
0:32:29	Date: 15May99. Picture of town.
0:36:25	The area of an access route under fire from a battle position.
0:37:37	Date: 16May99. UCK fighters in battle position.
0:40:39	Date: 17May99. UCK collection center.
0:48:56	UCK fighters in trench system at mountain slope (shots in the background).
0:49:36	Date: 08Jun99. UCK fighters (7 men) having a break.
0:30:22	Picture of a jet, probably NATO Tornado.
0:50:16	UCK fighters, having had their break, now in battle position.
0:55:10	Advance of UCK fighters across the terrain, presumably training.
0:57:58	Lining-up, presumably of recently recruited fighters. The PASTRIKU zone is mentioned. Commander Tahir SINANI delivers a speech in the honor of the killed in action.
1:06:17	Lining-up of UCK fighters; "GURI" appears.

1:08:34	“GURI” talks to 3 UCK fighters.
1:14:31	Date: 06Jun99, 1000 hrs. UCK fighters are digging a battle position in a wood area. 1800 hrs. Picture of mortar bursts in the ground. Date: 07Jun99. Crater of mortar burst in the ground.
1:17:08	Date: 10May99. 3 UCK fighters „picture of heroes“.
1:32:21	Date: 28May99. Bombardment of a town.
1:36:39	Date: 03Jun99. Interview with Commander ELASHI at the confrontation line.
1:38:20	114th Brigade in the area of MILLAROSI (phonetical identification). Interview with UCK fighter “PROFESSOR“, leader of the 2nd Group, 1st Platoon, 1st Coy, of the 121th Brigade „ELASHI Battalion“. According to him, the Serbs are weak and will not penetrate here.
1:40:08	Interview with leader, 1st Coy, of the 121th Brigade „ELASHI Battalion“. According to him, ammunition and food are sufficient, and the men are highly motivated.
1:43:10	UCK fighters in battle position. Preparation of food.
1:55:15	Date: 04Jun99. UCK fighters emplacing a mortar.
1:58:10	UCK fighters (approx. 25 men) marching across terrain.
2:00:35	Casualty collection center.
2:21:56	Date: 05Jun99. Leg operation of a female (presumably a mine injury). Interview with person with face injuries telling that he was arrested and questioned (and maltreated) by the Serb Military Police. 4 co-prisoners were designated to be shot; the injured managed to take to flight but sustained a gunshot wound. Interview with two persons reporting massacres in several villages in the area of SHAVARINA (phonetical identification) on 16Apr99.
2:39:30	Attendance of gunshot wound. END of the video tape.

**Note:**

Presumably, a great part of the pictures was made in the PASTRIKU zone.

If required, this video tape will have to undergo a closer look when having finished the sorting of the complete material.

12. Video tape No. 1.34 Title: -

Contents of the video tape:

1. Jetulla QUARRI “GURI” in KUMANOVO in May `01
2. “GURI” with UCK fighters in March `99

Time	Contents of pictures and remarks
0:00:00	
0:13:30	Together with a group of NLA fighters, “GURI” prepares an ambush along a winding road in the mountains.

0:21:00	Trench system in the valley, presumably in the same region.
0:42:40	“GURI” moves across the battle positions. The NLA fighters are instructed by “GURI” in handling their weapons and familiarized with their battle position.
0:43:50	Together with NLA fighters, “GURI” prepares a mortar position in the garden of a house (presumably in SLUPCANE).
0:47:00	16 NLA fighters at the double, probably extraction from the area of the battle position.
1:05:21	Date: 06May01. NLA fighters with mules on their march, presumably in SLUPCANE.
1:09:10	35 NLA fighters marching across covered terrain.
1:15:00	Subsequently, “GURI” familiarizes fighters with a trench system.
1:16:55	“GURI” instructs a fighter in the control of operations by means of a sketch.
1:19:05	“GURI” and NLA fighters at rest.
1:21:12	“GURI” together with approx. 60 NLA fighters passing through a town.
1:21:33	“GURI” and NLA group on a march (background: obstacle course).
1:32:29	Short radio conversation; alias: SHIPONJA (EAGLE) 1 and 2. Passenger car passes marching NLA group. “GURI” orders the lining-up of 46 NLA fighters for the flag parade. Subsequently, running training (presumably in the area of the HQ of the 113th Brigade in SLUPCANE).
1:32:29	Date: 20Mar99. UCK delegation (about 50 men) passing through a town. Approx. 70 UCK fighters marching on a mountain range. Subsequently, with camouflage material marching in the direction of a bridge.
1:47:30	“GURI” sits together with his UCK fighters in a paneled room talking to them.
1:54:30	Subject of the conversation is the fight against the Serbs and that “GURI” was a fearsome enemy.
2:01:00	“GURI” explains that he and Adem JASHARI have prepared war in 1992. Further names are mentioned: Daut TRESHANI, Jusuf CARI, Ramadan BELULI, Rahman Tafa. “GURI” orders 26 UCK fighters to line up and exercise. Subsequently, conversation with the men. END of the video tape.

**Note:**

Pictures of towns require a closer look. Presumably, the pictures show the region in and around SLUPCANE. The video tape is a means of self-portrayal (it is intended to show that “GURI” is able to operate all kinds of weapons, skilled in tactics and that he is a considerate leader).

13. Video tape No. 1.38 Title: 2 years

Contents of the video tape:

1. Event on the occasion of the 1st anniversary of the day of the killed in action of the 60th Brigade “KUMANOVA“ in SAVALEVA

Time	Contents of pictures and remarks
0:00:00	Event on the occasion of the first anniversary of the day of the killed in action of the 60th Brigade "KUMANOVA" in SAVALEVA.
0:09:42 0:14:42	Speech by "GURI"; contents: Commander "KUMANOVA" ordered him and the RECCE Battalion of the HQ to attack the villages of GREGERS, GRYX QERAVELES, and GURRAT KADNES (all villages identified phonetically). Safet KILSA from the 2nd Battalion "BOTAKOVA" provided the reinforcement in QAFA DULES (phonetical identification).
0:14:47	Speech by the Deputy Commander of the 2nd protected zone, Haxhi SHALA: He expressed his obligation to the killed in action.
0:16:40	Speech by Fadil KODRA (representative of the main staff of the TMK): He expressed his thanks for the participation of the auditorium in the event. According to him, the units operating in the PASTRIKU zone experienced the highest load. The special unit of the HQ was led by "GURI". The villages of GXKA QEVARELES (phonetical identification) and GRXKA LIAPUSHINKU (phonetical identification) were important strategic locations (support/supply of the Serbs); there, the UCK has inflicted heavy personnel and materiel losses. Thanks to the policy of HQ and UCK, Albanian bloodshedding was prevented. 1,811 fighters died as martyrs.
0:27:08	Speech by Safet SXLA, Commander of the 50th Signal Battalion: Commemoration of the killed in action.
0:28:35	Speech by unknown person: Glorification of the killed in action.
0:29:56	Cultural program, stage play – Treatment of the Albanians by the Serbs. Awarding of medals to the surviving dependants of the killed in action.
1:29:00	Laying of a wreath at the heroes' cemetery / memorial stone. The fighters have been killed in action in the period from 10May99 to 22May99.

**Note:**

Names of towns/locations have to be compared with the PASTRIKU zone.

14. Video tape No. 1.39 Title: -

Contents of the video tape:

1. Jetulla QUARRI "GURI" in the area of KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:00	Picture of a battle at night.
0:26:20	"GURI" preparing / inspecting a battle position in a front garden (i.a. M 760 A, cal 82mm / cal 60 mm; mortar position / NSV, cal 12.7 mm).
0:32:12	"GURI" welcomes / talks to other UCK fighters.
0:32:57	"GURI" inspecting weapons in the courtyard of a house (presumably in

	SLUPCANE).
0:38:07	“GURI” inspecting a <b>weapon storage site</b> in a red-brick house (machine guns, carbines, AK 47, antitank weapons, hand grenades); gives the order to transfer the weapons to another cache.
0:44:32	“GURI” inspecting weapons and battle position.
0:50:45	“GURI” supervises armament cleaning (30 men) in the courtyard of a house (SLUPCANE).
1:09:00	“GURI” enters a house (presumably the HQ).
1:13:00	“GURI” fires with submachine gun (SCORPION) from his room. Weapons and antitank mines are stored in the room.
1:27:40	Date: 21May01. Front garden of the above-mentioned house (shots in the background). “GURI” leads a battle using various weapons. END of the video tape.

**Note:**

“GURI’s” room is similar to that shown on the video tape with the questioning / torture scene. As required, all these rooms are located in the same building.

## 15. Video tape No. 1.03 Title: “GURI” - Shooting - Visit of the villages

Contents of the video tape:

1. Jetulla QUARRI “GURI” in the area of KUMANOVO in May `01

Time	Contents of pictures and remarks
0:00:00	Pictures of “GURI” and an NLA fighter are taken during a „posed“ fire fight at a wall in the terrain (cameraman located in the apron).
0:04:11	Assembly of the heads of the village of SLUPCANE with “GURI”, presumably in the HQ of the 113th Brigade in SLUPCANE.
0:32:12	“GURI” welcomes the heads of the village and an NLA delegation.
0:07:54	Head of the village clad in a white shirt: “When “GURI” goes to the KOSOVO we will accompany him...” “GURI”: “I would like to say some words regarding Commander MALIQI...” He is telling that the Commanders “MALIQI“, “SOKOLI“, and former Commanders (presumably from the KOSOVO) assembled after having taken their military oath to defend the Albanian soil. “MALIQI“, “SOKOLI“, and other Commanders do not dare to leave the Army. He does not talk much about himself since he is permanently with them, explains “GURI“.
0:09:23	„GURI“: “... <b>I remember well that SLUPCANE will become a free zone on 02May01.</b> “ (Hint to expulsion of Slav-Macedonians?) Then, I could have left SLUPCANE but I stayed there.“ According to “GURI”, he was able to apply the complete weapon potential in SLUPCANE.

0:11:42	<p>“GURI”: “For the first time, SLUPCANE is a free zone but the Macedonian Armed Forces try to get their feet into the region. ...SLUPCANE has become a 2nd DRENICA with sons who are strong in holding out (hint to the recruiting of fighters from that village)... The NLA enters the stage and by and by the flags of the Albanians and the UCK are flowering.”</p> <p>Then, he is telling that he has fought side with JASHARI in 1998 and that it was JASHARI’s course that led “GURI” to this region.</p>
0:13:42	<p>The heads of the village express their thanks to “GURI” that the NLA had established their central command point in SLUPCANE. This is followed by the glorification of “GURI”.</p> <p>“...all will follow him independent of the fact that they are Albanians from FYROM, Montenegro or the Kosovo...”</p>
0:16:13	<p>“GURI”: “My fighter’s name dates back to `92.” Then, he is telling the story of the beginning of the conflict, of police raids and detainment (in SUVA REKA) (7 times, the Serb police came to his house).</p>
0:17:39	<p>“GURI” says that he was expelled but that he returned again and again. According to him, the Serbs have murdered and maltreated.</p>
0:18:41	<p>“GURI”: “...then, in `98, the weapon of Adem JASHARI was triggered (in DRENICA). ...this started the war in your area; you were very late in organizing yourself but better late than react not at all... SLUPCANE will soon be a second DRENICA, then I will inform you (context with video tape No. 1.25 0:09:40?). ...up to that date, patience is required. You have supported the Army to a high extent; your sons fought for us... KOSOVO and FYROM will be free at the same level. We do not ask for much, we only want to have our freedom. We will be as free as all the Western countries.”</p>
0:22:00	<p>The NLA delegation leaves. One of the heads of the village is reciting a glorification poem: “... no freedom without war and blood; in SLUPCANE, the war has started...”</p>
0:28:16	<p>This is followed by words of praise for “GURI”.</p>
0:29:00	<p>“GURI”: “The commanders “MALIQI“, “SOKOLI“, and “TIGRI“ are experts in strategy. “TIGRI“ was present when positions were collapsing... Commander “TIGRI“ says that he will return to VACINCE and fight against the SLAVs... The commanders have made progress in theory and practice, have become experts. Even when they are killed in action, their course will be continued...”</p>
0:33:44	<p>This is followed by a story on the hero “TIGRI“.</p>
0:36:56	<p>“GURI” tells a story of the fight side with Commander “KUMANOVA“.</p> <p>One head of the village (blue shirt) says that his 10 years old son also wants to join the UCK.</p>
0:40:19	<p>“GURI”: “We knew when the fight started but we do not know when it will be finished... I will leave one hand on the KOSOVO and the other on FYROM.</p>
	<p>There will always be war; you are turning your bag on the war but it will not stop (“GURI” explains that these are the words of Commander “MALIQI“).</p> <p>End of the conversation.</p>

0:43:31	<p>“GURI”, with the commander of the group at his side, orders the lining-up of the NLA group (25 to 30 men) in covered terrain.</p> <p>This explains that SLUPCANE was declared a free zone on 02May01.</p> <p>This is followed by the expression of thanks for the excellent work.</p> <p>In the background, UN vehicles (presumably monitors) are driving along the road.</p>
0:49:56	<p>The mentioned group is marching along an extensive bend of the road to a battle position area where the current situation is questioned.</p> <p>The situation: 2 armored vehicles and 2 tanks are situated 200 m left of the opposite house in the village with their barrels leveled at SLUPCANE and ORIZAR.</p>
0:52:39	<p>“GURI” orders fire restraint.</p> <p>END of the video tape.</p>

**Note:**

The contents of „GURI’s“ stories is a hint that “GURI”, having laid down the arms, may have established contacts with the AKHS. The conversation with the heads of the villages may be posed in order to show that the inhabitants of SLUPCANE are backing the NLA though the contrary may have been the case.
