

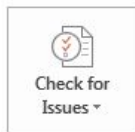

Entries concerned non-essential are not included in the protocol.

The reports on combat actions cover the period from January `99 to the arrival of the KFOR forces in June `99. Based on these entries, at present, no conclusions can be made that war crimes have occurred in this period.

Since the reports on pages 2 to 4 of Document 2.44 correspond to the entries made between 04 and 11 July, Document 2.44 probably is a guard duty log of the HQ of the former 60th Bde that was converted into a TMK Command. Presumably, this HQ is located in MUZICANE (EN 08 00).

Reservist at the Officer Training School in BILECE; subsequently, platoon leader in SARAJEVO. In SARAJEVO release as NCO. In SUVA REKA (DM 86 90), Mefail HELSHANI got the instruction to deploy to PROKUPLIE as reservist. HELSHANI did not follow this instruction for he would not have felt safe due to the situation so that he was imposed with a fine. On 15Mar1985, HELSHANI got a job in the rubber works in SUVA REKA (DM 86 90). End 1989, the Serbian police pronounced a prohibition on work. On 27May98, he joined the UCK in LUCNICA (DM 91 00) and participated in 2 combat actions, where he was injured in the course of the second fight. On 06Dec98, he became Company Commander of the "BUDAKOVA Bn" in LANISTE (DM 96 93).

**Note:**

The UCK had an organization system adequate to that of the Armies of the communist and/or post-communist area. It becomes obvious that the UCK was well organized in many fields. The management comprises complaints, regulations for leave, structure of the combat elements and operational planning. Remarkably, many awols were reported which could be an indicator that the much-vaunted fighting morale and operational readiness of the "Albanian liberation fighters" rather applies to a small core than to the masses. For this reason, at first, obviously a hard core of the fighters of the KOSOVO conflict appeared in the theater in FYROM, and the FYROM population was mobilized subsequently (sometimes by force).
